

Pre-Camp Screening Guidelines

Camp Sequoia staff will be fully vaccinated against COVID-19 for season 2021. As we've discussed, we encourage vaccination of eligible campers (currently age 12+) before the start of the camp season. The following pre-camp screening guidelines are designed to help us bring together a safe community that will set up our campers for success in 2021, building on the foundation of our 100% COVID free 2020 season.

Vaccinated Campers

For campers who are 12+ who receive their second vaccination by 7/4, their pre-camp screening will consist of **a copy of their CDC vaccination card provided digitally to our office no later than 7/11**. If we do not receive documentation of the vaccination card by this date, campers in this group will be required to follow the protocol below.

Unvaccinated or Partially Vaccinated Campers

For unvaccinated, partially vaccinated, or campers without documentation of vaccination by 7/11:

There are **two** pre-camp screening requirements. We have again partnered with [Vault Health](#) to allow you to do an at home, video monitored saliva-based PCR test. Directions on how to order this test as well as the timeline so that we get results prior to arrival day are included below.

Part 1: 7/4 ORDER THE PCR TEST FROM VAULT HEALTH.

- **7/11** BEGIN SCREENING AND DOCUMENTATION PER DIRECTIONS BELOW. We will send you a reminder and the appropriate template shortly before this day.
- **7/15** LOGIN TO VAULT HEALTH WEBSITE AND **ADMINISTER PCR TEST IN VIEW OF ONE OF THEIR PROCTORS**. PLEASE PLAN TO DO THIS SO THAT YOU CAN DROP OFF THE UPS OVERNIGHT **SHIPPING NO LATER THAN 3 PM**.
- **7/16** END OF DAY. RECEIVE EMAIL WITH TEST RESULTS FROM VAULT HEALTH AND FORWARD TO INFO@CAMP-SEQUOIA.COM

Part 2:

For the week (7 Days) prior to camp beginning on 7/11, unvaccinated or partially vaccinated campers need to complete a signed/dated form (provided to you electronically the week of 7/7) that indicates compliance with CDC best practices and parental screening of camper for symptoms daily. While specific state-based guidance may change as we approach camp, this screening tool is in place to provide an extra layer of protection for our community and this signed and dated document **will be required** on arrival day. If there is an event during the week preceding camp (potential exposure, fever etc.), in addition to a PCR test screening that is negative within 72 hours of camp, please let us know so that we can discuss appropriate next steps. In order to maintain the integrity of the PCR testing we recommend that campers and their families err on the side of caution specifically during this one-week period. This means minimizing higher-risk behavior by avoiding groups, especially large groups, in indoor spaces and practicing appropriate social guidelines in accordance with local, state and federal guidance.

COMMON MISTAKES TO AVOID:

- NOT ORDERING THE VAULT TEST IN A TIMELY MANNER
- ADMINISTERING THE VAULT TEST BEFORE THE REQUIRED DATE. IF YOU ADMINISTER IT TOO SOON, YOU'LL BE REQUIRED TO DO ANOTHER ONE WITHIN THE SPECIFIED TIMEFRAME
- MISSING THE UPS SHIPPING WINDOW ON 7/15. PLEASE KNOW WHEN THE LAST PICKUP IS AT YOUR LOCAL UPS. WE ARE USING 3 PM AS A SAFE GUIDELINE, ALTHOUGH YOU MAY FIND LOCALLY THAT THERE ARE LATER DROP-OFF OPTIONS.

ADDITIONAL REMINDERS:

- As a reminder, our pharmacy has indicated that they have availability to help with second shot vaccinations for campers who receive their first shot before camp, but are unable to get their second one. Please contact us if this situation applies to you.
- Any Campers 14+ who wish to join us on our Hawaii Adventure after camp in July will need to be fully vaccinated in order to participate.
- **Medical paperwork and prescriptions to our pharmacist for 2nd session are now past due.** Please make sure that you have all of the pieces in our hands ASAP as we don't want anyone to lose their spot at Camp Sequoia this summer because of incomplete or tardy paperwork.
